While we expect to make some similar grants again, we also believe that the Innovation Delivery approach can be effectively implemented by tapping existing city staff—drawn from units such as quality assurance, performance management, or innovation—or some combination of new and existing staff. In this upcoming cohort of grants, Bloomberg Philanthropies aims to fund teams through a range of implementation and staffing structures—e.g., small teams, large teams, dedicated staff, shared or seconded staff, stand-alone teams, teams that sit within existing executive branch units. We are looking for cities to use this approach in diverse and customized ways that tap existing assets where possible and practicable.
